### Terms:

1. Breeding Fee – Payable before semen shipment. Payments to SHE WILL EQUINE, LLC by Check, Zelle, Venmo or Paypal. Collection fee payable directly to EMCO (Ocala, FL).
2. The Mare shall be in healthy and in sound breeding condition and free from infection or disease and that all necessary veterinary examinations and treatments will be carried out in order for the mare to conceive and maintain her pregnancy.
3. All proper paperwork must be completed and all fees paid before the shipping of semen.
4. Contact Rising Star Farm to arrange collection and shipment of semen: 512-751-2390. All shipping cost associated with the shipment of semen will be at the Mare Owner's expense. Please notify Rising Star Farm by 8 p.m. EST the day before the requested collection\*. Late orders will be filled if possible. Cancellations must be made by 8:30 on the day of collection. PLEASE DO NOT CONTACT VIA FACEBOOK - USE PHONE OR EMAIL - PHONE IS PREFERRED.
5. It shall be the sole responsibility of the Mare Owner to:
  - a. Insure that the semen is administered by a licensed veterinarian on the day of delivery.
  - b. Insure that their veterinarian agrees to follow any and all instructions of the collecting veterinarian, if necessary, otherwise all guarantees become null and void.
  - c. Assume all responsibility for the condition of the mare and bear all risk of loss or damage to the mare by death, illness, injury, infection or otherwise, and agrees to hold Stallion Owner harmless.
6. It shall be the responsibility of Stallion Agent to:
  - a. Deliver live semen provided notification is given as described above\*
  - b. Guarantee live semen to leave the Stallion Agent and release of responsibility to Stallion Agent for delays, cancellations or loss of containers from aircraft or any other means of transportation.

7. Stallion Agent requires that:
  - a. A uterine culture must be performed on the mare by a licensed veterinarian if a mare fails to conceive after 2 cycles.
  - b. Mare should be examined by a licensed veterinarian at 16 and 45 days after last insemination. Stallion Agent must be notified of her pregnancy status at the time or all guarantees are null and void.
  - c. Mare owner must provide a conformation picture and pedigree of mare.
8. It is understood that the service fee is for a live foal that stands and nurses in 2027. The live foal guarantee applies only if the Stallion Agent is notified within one week from the death of foal. A statement must accompany this notice from a licensed veterinarian.
9. Prior to the shipment of semen, it is strongly recommended that Warmblood Fragile Foal carrier status of the mare is determined. LFG status may be nullified if carrier status is unknown.
10. If the mare proves to be barren or does not produce a live foal in 2027, the Mare owner will be entitled to return privileges for the same mare or another mare approved by the Stallion Agent that season only. If Mare is to be rebred and mare owner fails to contract the Stallion Agent for semen shipment in 2027 then any and all fees paid shall be nonrefundable and the contract is thereby canceled.
11. It is further agreed that should the said stallion die, be sold by the owner, or become unfit for service before servicing Mare or if Mare named in the contract dies or becomes unfit to be bred then this contract is and shall be null and void.
12. This contract shall not be assigned or transferred and in the event said Mare is sold, the fee if unpaid shall immediately become due and payable and not refund shall be due under any circumstances. Each contract is valid for one mare and doses may not be split.
13. When Agent of Stallion signs and returns one copy of this contract, it will be a binding contract on both parties subject to the above terms and conditions.
