ACKNOWLEDGEMENT: By signing this agreement Client acknowledges, agrees and understands that UK9 has not represented, promised, guaranteed or warranted that Dog can be trained, that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems or that the training will last for any particular amount of time as each dog is different in regards to ability, breeding and temperament. Client further acknowledges, agrees and understands that they must practice with their dog to maintain what they learned during each lesson and that follow-up and scheduling of future training sessions is their sole responsibility.

Policies:

_____(client's initials) I agree and understand that a "no-show" for a scheduled appointment will be counted as a lesson if a refund is requested. I further understand and agree that a program may include admission to classes only when program is paid for in full and that classes have no cash-out value. I further agree that lesson duration is determined by the trainer at the time of service and that time spent during appointments discussing my dog, dog training and/or behavior is considered training/lesson time and that I must practice with my dog in-between appointments in order to get the most benefit and success from any training program. I further understand and agree that UK9 does not guarantee any group or specialty class will always be held, or at any specific location, and that if my dog is aggressive, it can be prohibited from attending UK9 group classes.

TERMINATION:

_____(client's initials) UK9's services shall terminate if (a) in UK9's judgment Dog is dangerous or vicious to UK9 or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement, or (c) . The trainer reserves the right to terminate the training program at any time due to lack of cooperation from the client. (d) Client requests service termination. I understand that if I terminate this agreement at any time, I am legally bound to the refund policy listed in the "REFUNDS" section items (a.) through (c.) which I initialed below. I further understand and agree that UK9's duties shall terminate but all other provisions of this Agreement shall remain in full force and effect.

REFUNDS:

_____(client's initials) In consideration of the acceptance of this registration, and the holding of classes, workshops, lessons or any other interaction between client, clients dog and trainer, Client agree to hold and all trainers, independent contractors, employees, assistants, or apprentices, the premises upon which the classes, workshops, lessons or other interactions are to be held, harmless from any claim for loss or injury, both direct and indirect, to any person or thing by any act of any dog or any person while in or upon any premises or grounds or near any entrance thereto. Client hereby waives any and all claims or actions that Client or my representatives may have, from any and all personal injury to myself, my dog, children, or harm to property or persons caused directly or indirectly through actions or inaction of self or others, by acts that might occur in dog activities, any other format of dog activities or secondary dog activities without trainer present or engaged. I personally assume ALL responsibility and liability for any such claim. Client further agrees to hold the aforementioned parties harmless from any claim of loss of any dog. Client assumes the sole responsibility for and agree to indemnify and hold harmless the aforementioned parties from any and all loss and expenses, including legal fees, by reason of the liability imposed by law upon any of the aforementioned parties for damage and expenses.

PROPERTY DAMAGE:

_____(client's initials) I agree to assume all responsibility for any property damage caused by my dog to United K9 Academy during training.

CURRENT VACCINATIONS:

_____ (client's initials) I also acknowledge that the dog I am currently handling, or sending to United K9 Academy for training, is up-to-date on all vaccinations and free of parasites to include fleas and ticks.

POTENTIAL RISKS:

_____ (client's initials) I am aware that there are inherent risks and hazards involved in activities with and around dogs and in the general public; and I, and any person participating on my behalf, voluntarily participate in these activities with knowledge of potential dangers. I'm aware that any dogs, regardless of training, handling, or environmental circumstances, are capable of biting, and expressly acknowledge the risk therein. I agree that a child under the age of 16 years must have an adult present during training.

INJURIES

_____ (client's initials) I agree to assume all responsibility for any injuries to my dog, or other dogs in the area, that may transpire as a result of my negligence and failure to follow the instructor's or trainer's guidance on training methods or training tools. I agree to assume all responsibility for any injuries to other people or dogs caused by my dog that may transpire as a result of training by myself or United K9 Academy.

No Shows, Cancellations, Tardiness & Reschedules Policies:

_____ (client's initials) I acknowledge, understand and agree to the following No Show, Cancellation, Tardiness and Reschedules policy:

- (a) 24-hour notice is required to reschedule a session. Failure to do so will result in cancellation of the session.
- (b) If I am late for a lesson, I understand that tardiness results in missed lesson time and will not be made up. If I am late to a group class, I understand that tardiness results in missed lesson time and will not be made up.
- (c) I agree and understand that a "no-show" for a scheduled appointment will be counted as a lesson.
- (d) Rescheduling a board and train less than 48 hours from the drop off time is subjected to a \$50 Rescheduling Fee.

TRAINING MAINTENANCE AFTER COMPLETION OF LESSONS

_____ (client's initials) I agree to assume responsibility for maintaining my dog's training after professional training is complete. If United K9 Academy deems that maintenance training has not been performed, or the dog has not been worked after bringing dog home from training, the Satisfaction Guaranteed contract is null and void. I also understand that there is no money back guarantee on training. I understand that different dogs will yield different results after training. A good faith effort will be made to ensure each dog receives adequate training and that each owner is educated on the dog's training to ensure harmonious relationship after training is complete. United K9 Academy is responsible only for the aforementioned training outlined above. Additional training not outlined in this original will incur additional training fees.

FOLLOW UP LESSONS FOR BOARD AND TRAIN PROGRAM

_____ (client's initials) Follow-up private lessons for Board and Train program training are provided here at United K9 Academy. Lessons are given in the event that the owner has maintained training and the dog needs a simple reminder to continue a certain behavior. Private lessons do NOT address any additional training that was not guaranteed in the board and train program. If the owner requests that the follow-up lesson be done in home, owner agrees to pay a per mile travel fee. If United K9 Academy deems that the reason for the dog's disobedience is due to lack of maintenance training by the owner, the follow-up lesson will not be free of charge. A private lesson fee will be assessed prior to the lesson. It is the owner's responsibility to continue reinforcing good behavior and training in order to ensure the dog's learned behaviors continue post-professional training.

BOARD & TRAIN PROGRAM

_____(client's initials) Board and train programs do not guarantee results. In the basic foundations program, dogs will be taught sit, down, stay, heel, come when called and place commands. They will be socialized and exposed to training in new environments. They will be taught home manners such as no jumping, no mouthing, not chewing; however, these results are not guaranteed. Continued training is a must even after board and train program is completed. The board and train programs do not guarantee results. Training offered includes off leash training, service dog training, tricks training and behavior modification training. Individual dogs will bring about different results. The age, maturity, breed and previous amount of training will dictate the progress your dog will make in the board and train program. One go-home lesson is included with each board and train. This lesson is 1-2 hours long and is completed with the owner present. Board and train does not cover pick up or drop off costs.
