Happy Birthday to the U.S. Coast Guard





The U.S. Coast Guard is one of the oldest organizations of the federal government. Its official history began on August 4, 1790, when President George Washington signed the Tariff Act authorizing the construction of ten vessels to enforce federal tariff and trade laws and prevent smuggling. It was then established, by Secretary of the Treasury Alexander Hamilton, as the Revenue Marine Service. It later became the Revenue Cutter Service and, in 1915, was combined with the U.S. Lifesaving Service (formed in

1878) to become the Coast Guard. The Coast Guard served as the nation's only armed force on the sea until Congress launched the Navy Department eight years later.

The United States Coast Guard, is a military service within the U.S. armed forces, charged with the enforcement of maritime laws. It is our maritime security and law enforcement service branch of the United States Armed Forces and one of our country's eight uniformed services. The Coast Guard also operates ice cutters, "We do this job because every once in a while someone is out there without hope, desperately praying for their life, and we get to be the answer."

rescue helicopters, lake patrol and protects our borders. Search and Rescue is one of the Coast Guard's oldest missions. They assist in preventing loss of life or injury and minimizing property loss at sea by rendering aid to those in distress.

The US Coast Guard consists of approximately 42,000 officers and enlisted personnel, in addition to civilians. It is under the jurisdiction of the Department of Homeland Security. In time of war, it functions as part of the U.S. Navy and is under the direction of the president.
