V. Partner Updates

- a. Shelters/Day Centers/Street Outreach
 - i. FCRM April 2 last sleep in Chapel area, reducing shelter capacity by 18-20 and winter shelter is closing on April 16th, reserved guests can stay during the day
 - ii. HNC/CWS closing on April 15th, to date 402 individuals enrolled in shelter, working with community partners to prepare for the influx of people spreading throughout the community, working on getting people housed through navigation, day shelter is
 - iii. Hope at Miracle House, openings for two families
 - iv. CBOCES Street Outreach program to reach out to youth, host home program and can serve people 12-17
 - v. Almost Home part time housing navigation position posting on Monday for southern Weld County
 - vi. LRC Few weeks away as the South Railroad site, 35 capacity, working on what to do for people who can't make it or stay at the site, will have overflow capacity, 32 people at LRC, have been sheltering people in motels but will be exiting them soon, it would be a great way to communicate regionally about capacity to keep in touch, looking for space for people with mobility impairments, are also hiring for shelter positions
 - vii. OFC Project Homeless Connect is happening April 14 at Atzlan from 10-2, will have a lunch
 - viii. FHN 2 openings in overnight program, access to use day center with a phone screen and intake
 - ix. Catholic Charities Larimer close to capacity, not turning people away, have a couple of spots in extended stay for men and vets, in Greeley, extended stay program is getting close to capacity, been leaning into providing emergency shelter for women and families

b. Housing

- i. N2N looking for property manager, screening process added to going well, question, they do have to have been served a demand for service or eviction notice
- c. City/County/Government
 - i. The City of Greeley launching Homelessness to Housing case management team, 60 vouchers attached,



- ii. Weld County has hired two housing case managements to keep people housed through their emergency
- iii. Together CO provided updates on housing related legislation
- d. Youth Services
 - i. TMH Youth Shelter is underway, plan to open in August 2024, TMH is transitioning out Host Home program into RRH for youth 18-23,
- e. Veteran Services
 - i. SSVF getting ready to wrap up grant year, May 11 Stafford Act will no longer in place, will change how their programming will change to now have restrictions of rental assistance
- f. Behavioral Health
 - i. None
- g. Justice System/Public Safety
 - i. City of FC has formed the HOPE Team within the Fort Collins Police Department, working closely with Street Outreach
 - ii. Kendra Bornhoft now Director of Weld Justice Services and is looking into people exiting incarceration to homelessness and requested people reach out to make connections
- h. Other
 - i. UWLC EFSP applications closed; also working on event for Fair Housing month (April)
 - ii. UWWC EFSP applications are still open through April 3
