# Celebrating 55 Years of the passage of the Fair Housing Act



Fifty-five years ago on April 4, 1968 - an assassin's bullet cut short the life of the Rev. Dr. Martin Luther King Jr., a Fair Housing leader and prominent Voice for passage of the federal Fair Housing Act.

Dr. King's tragic death triggered a dramatic Seven Days on Capitol Hill in Washington, DC. Congressional action on the Fair Housing bill had stalled. Yet, through the united efforts of civil rights advocates and forward-thinking legislators, Congress passed the landmark Fair Housing Act - and President Lyndon Johnson signed it into law on April 11, 1968

# 2022 Notice of Funding Opportunity (NOFO) CoC Program Competition

## **FY22 CoC Program Funding Announced**

Northern Colorado has been awarded \$1,461,940 in Continuum of Care Program dollars to continue to fund four permanent supportive housing programs, one cross-county rapid rehousing program, as well as essential funding for CoC administration, coordinated entry (CAHPS) and data management (HMIS).

The Continuum of Care (CoC) Program is designed to promote a community-wide commitment to the goal of ending homelessness; to provide funding for efforts by nonprofit providers, states, Indian Tribes or tribally designated housing entities (as defined in section 4 of the Native American Housing Assistance and Self-Determination Act of 1996 (25 U.S.C. 4103) (TDHEs)), and local governments to quickly rehouse homeless individuals, families, persons fleeing domestic violence, dating violence, sexual assault, and stalking, and youth while minimizing the trauma and dislocation caused by homelessness; to promote access to and effective utilization of mainstream programs by homeless individuals and families; and to optimize self-sufficiency among those experiencing homelessness.

As the weather warms in northern Colorado, it brings reduced options for emergency shelter.

Greeley



The Cold Weather Shelter (CWS) is closing April 15th. The CWS provided 60 low barrier emergency shelter beds to individuals experiencing homelessness during the winter months that will no longer be available. The **Housing Navigation Center** will continue to be a safe place for people to access services and resources Monday-Friday 8:30am-4pm.

<u>Catholic Charities- Guadalupe</u> will continue offer a limited number of overflow shelter beds for single

women and families from 8pm-8am. Women and families needing overflow shelter can call 970-353-6433.

#### **Fort Collins**

The <u>Fort Collins Rescue Mission</u>, which serves single men, will be closing their winter overflow shelter location on April 16th and earlier in April had to close use of their chapel for additional overflow. These changes have reduced the number of available by roughly 40 shelter beds.

<u>Catholic Charities-Samaritan House</u> will continue to shelter families and single women at the same capacity.

#### Loveland

At this time, the <u>Loveland Resource Center</u> will continue to shelter single adults at the same capacity.

### HUD Training Spotlight: RRH Serving Households with Limited or No Income

As part of a continuum of interventions in a housing first-oriented system, rapid rehousing (RRH) programs should focus on serving households who experience the most significant barriers to obtaining and maintaining stable housing, rather than screening them out. This includes serving households with very limited or no income at program entry.

This discussion talked about how effective rapid rehousing programs are designing services and preparing and equipping program staff and participants to navigate the challenges of increasing income and decreasing expenses to featuring community leaders, housing thought leaders, and persons whose lived experience dramatizes today's housing crisis promote housing stability.
