FY2023 CoC Awarded \$1.57M in CoC Program Funds

In September of 2023, the NoCO CoC successfully submitted our CoC Application and Individual Project Applications to the CoC Program Competition. In February we received notice that **Northern Colorado was awarded \$1,570,991 in CoC Program funds, an increase of more than \$100,000 over FY22 CoC Competition.**

Projects awarded include:

- Redtail Ponds PSH - \$384,433
- Division of Housing PSH Vouchers - \$315,728
- Northern FrontRange RRH - \$299,002
- DV Coordinated Entry - \$175,032
- Mason Place PSH - \$102,443 ***newly funded***
- Homeward Alliance HMIS Lead - \$88,527
- PSH in Loveland (4th St. PSH) - \$74,388
- NoCO CoC Planning Project - \$73,173
- StarRise PSH - \$58,265 ***newly funded***

The CAHPS Steering Committee reviewed representation of sectors/skills/experience prior to this election cycle and is looking to prioritize applicants who represent one or more of the following areas a) Youth, b) Outreach c) Lived Experience d) Co-Response/Behavioral Health, and/or e) Weld County.

New members are expected to serve on the committee for at least one year, but up to three years, and engage in the following ways:

- Attend at least one of every type of case conferencing meeting (i.e., Veteran, Identification & Assess, Match, and Navigate)
- Review CAHPS Policies & Procedures
- Sign up for at least one Built for Zero learning session/webinar
- Attend at least 75% of monthly meetings (*currently scheduled for the fourth Thursday of every month from 3-5pm)

The Division of Housing is pleased to announce the release of the annual **Homeless Prevention Activities Program (HPAP) Request for Applications (RFA)** for the fiscal year 2024-2025.

The HPAP program provides funding to nonprofits and local governments across Colorado to prevent at-risk households, including youth-headed households, from experiencing homelessness. HPAP funds help stabilize their housing situation by providing temporary financial assistance and housing-focused case management. Here are the RFA details:

- Applicants may request funding of up to \$50,000 per application, per organization
- Grant term: July 1, 2024, to June 30, 2025
- Application deadline: April 1, 2024, by 5 pm MT

Equal Access Assessment Tool

The Equal Access Assessment Tool (EAAT) provides specific action steps for HUD recipients and subrecipients to meet the requirements of the **Equal Access Rule** in shelters and other facility settings. It helps assess their compliance with regulations and best practices.

The tool is organized under the following Equal Access topics:

- Ensuring Access
- Harassment Policy
- Managing and Resolving Violations
- Confidentiality Practices
- Data Collection
- Privacy and Safety Practices

Who Should Use This Tool?

This tool is for agencies' internal use only. This tool is intended for administrative staff; however, front line staff may also benefit from reviewing the tool and assisting in the assessment process.

Note: This tool was developed with Continuum of Care (CoC), Emergency Solutions Grants (ESG), and Housing Opportunities for Persons With AIDS (HOPWA) recipients in mind, however this tool is applicable to all Community Planning and Development (CPD) recipients and subrecipients.

CAHPS is the community-driven process to identify, assess, refer, and house all people experiencing homelessness in Weld and Larimer Counties.

Since 2016, the CAHPS process has helped house 1,846 households.
