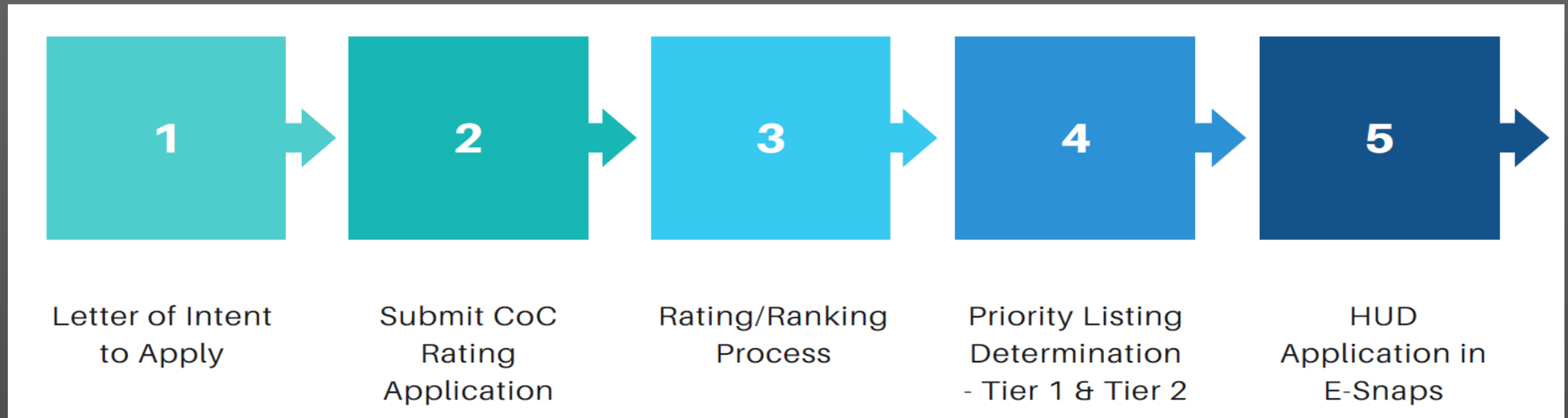

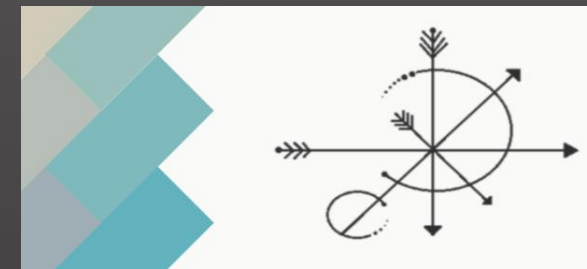
CoC NOFO Competition Overview

Basic Parts of Competition



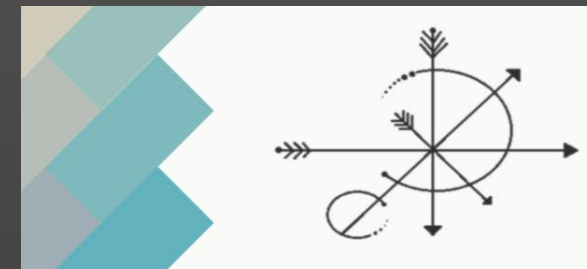

- Submission of Project Rating Application – DUE 9/20/2024
 - [NoCO CoC Project Rating Application - RENEWALS Survey \(surveymonkey.com\)](https://www.surveymonkey.com)
- Rating & Ranking Deliberation
 - CoC Rating Committee will review application and score them on pre-determined criteria
 - 9/23/24-10/1/24
 - Application clarification responses due 10/2/24
- Priority Listing Determination
 - Acceptance, Reduction/Reallocation, Rejection Notification 10/14/24
 - What is Reallocation?
 - Appeal of Listing due 10/17/24
 - Must provide specific justification for appeal consideration
- Submission of *E-Snaps* Application due 10/18/24
 - Final Revisions/Amendments due 10/25/24



Local Competition – Renewal Project Application

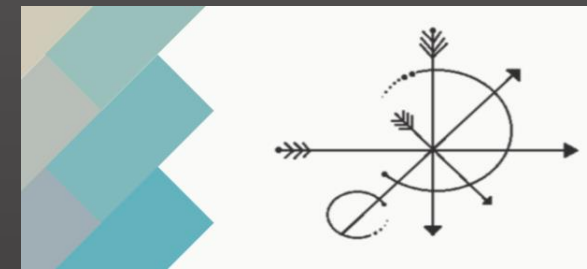
Why? To allow local evaluative process to review and prioritize which projects should receive limited HUD funding to address homelessness

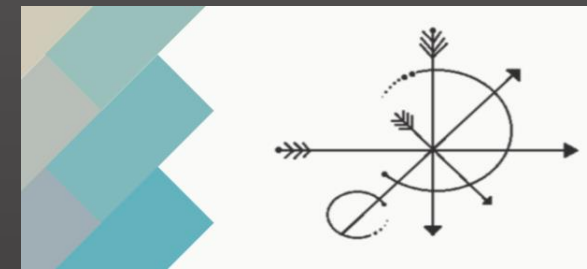

Priority Listing/Tier 1 vs. Tier 2

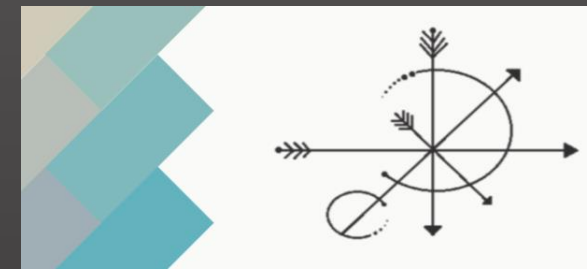
- Tier 1 = \$1,348,036
- Tier 2 = \$366,025 (\$149,782 in Renewal \$; \$216,243 in Bonus/Expansion)

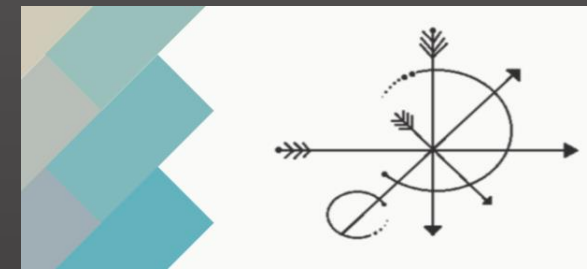

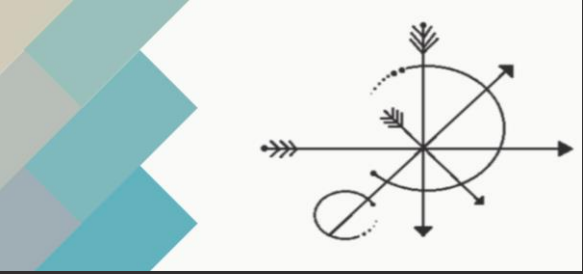
