v. Member Updates/Info Sharing

- a. Shelters/Day Centers/Street Outreach
 - City of Loveland 20 spots at LRC, 4 humanitarian tents behind center but only 2 of them work, utilizing motels, second sites with tents happening in early Feb., sheltered about 80 people during the cold spell in partnership with Embassy
 - ii. FHN 2 vacancies in overnight program, day center and case management is open for families
 - iii. FCRM capacity of 106 in main location (80 24/7 beds), partner with city to use overflow to expand to 146; in the process of exploring whether can build a new shelter, applied for Transformational dollars; Paula Ordaz is good point of contact related to questions
 - iv. CO Rural Collaborative received street outreach grant, expanded HOST Home; YHDP – creating statewide plan for youth homelessness
 - v. Catholic Charities in Larimer has both extended stay and overflow, having some challenges security, started doing resource navigation with overflow
 - 1. Joe Sarr is new Executive Director over both Larimer and Guadalupe
 - vi. Guadalupe is full for extended stay, do have overflow but are not seeing a lot of utilization
 - vii. Housing Navigation Center Resource Navigator team is fully staffed, day shelter has showers finished, CWS has capacity of 60 and is full every night, expand capacity through partnerships and motel stays, applied for several street outreach grants,
 - viii. Family Promise has spaces open, day center is also open
 - ix. AWP busy but encourage people to call crisis line, no major updates



x. Hope @ Miracle House – South Weld/Fort Lupton, has a room available for family, using

- b. Housing
 - Housing Catalyst opening waitlist for project based housing for 2 and 3 bedroom households, go to housing catalyst website to put info in to get notification of waitlists opening; received additional mainstream vouchers for PEH that comes with extra dollars to help getting people into housing;
 - ii. High Plains Housing Development applying for CHFA tax credits, if awarded in May they would be building project in 2024, project is 58 1-bedroom units, VOA would be lead services provider
 - iii. RMHS have plenty of money for veterans experiencing homelessness, contract with law firm
 - iv. Weld County Human Services finished process Emergency Rental Assistance (ERA), but county received additional funds to hire housing stabilization case managers
 - v. UWWC Homelessness Prevention Assistance available, EFSP will be open up applications for next round
 - vi. N2N First Month's/Deposit Larimer County, working on reducing wait time
- c. Youth Services
 - i. The Matthews House are taking community referrals but just aren't able to assign them right away; HOST Home program, have waitlist; shelter development – have conducted focus groups with shopworks
- d. Veteran Services
 - i. VA new staff member outreach social worker, should know within 2-3 days of whether we reached out goal nationally of housing 38,000
