2025 Point in Time Count - Night of January 28

The 2025 NoCO CoC Point-in-Time Count (PIT Count) and Housing Inventory Count (HIC) will be occurring during the last week of January, with the night of the count likely being Tuesday, January 28, and then the primary canvassing day on Wednesday, January 29. As with the last few years, we will be making a sheltered and unsheltered count. This year we are also seeking to do a more substantial count of youth who are without housing.

The PIT Count and HIC are HUD-required annual CoC activities, provide the CoC an increased sense of the amount and extent of homelessness in the region, and can influence the level of future funding received from HUD. 


Progress Continues towards Ending Veteran Homelessness

Feedback Opportunity: Participate in HUD's HMIS Data Standards Change Process

HUD invites stakeholders to contribute to the Homeless Management Information System (HMIS) Data Standards update for Fiscal Year 2027. This critical process helps ensure data collection efforts effectively support homelessness prevention and service provision. Input is sought from individuals with lived experience of homelessness, frontline staff, service providers, organizational leadership, and HMIS administrators to identify changes that can improve how data is collected and utilized.

HUD encourages input from a diverse range of perspectives, including those being served in homeless response systems and those directly engaging with data collection.

Participation in this process will help shape the HMIS Data Standards to better reflect the realities of homelessness and improve the delivery of critical services.

Funding Opportunity: DOH 2025 Creation of Supportive Housing RFA

In November, DOH announced the 2025 Permanent Supportive Housing (PSH) Request for Applications (RFA) to promote the development of housing solutions for individuals and families experiencing or at risk of homelessness. This RFA provides enhanced financial support to developers working to create innovative PSH opportunities across Colorado.

Coordinated Assessment Housing Placement System (CAHPS)

CAHPS is the community-driven process to identify, assess, refer, and house all people experiencing homelessness in Weld and Larimer Counties.

So far in 2024, the CAHPS process has helped house over 400 people!

Through CAHPS, the NoCO CoC is participating in the <u>Community</u> <u>Solutions Built for Zero Initiative</u> to reach Functional Zero to end Veteran and Chronic homelessness.
