# **AAK 2024-2025 Assessment Schedule**

#### **August 8th - August 16th**

**DIBELS BOY Grades K-5** 

MCLASS Amplify-Districts must annually report the READ Act administered interim and diagnostic assessments along with the core, supplemental, and intervention instructional literacy programs for grades K-3 for each school operated by the LEP (including charter schools). (any new students after the first day, within 30 days of starting)

# August 12th - August 23rd

i-Ready K-5-Diagnostic (Reading and Math)

AAK uses iReady as a local assessment to gather baseline and diagnostic data on our students to support data driven decision making. This data is used when creating and evaluating our Unified Improvement Plan and creating academic interventions for our students.

WIDA/W-APT (first 30 days) AAK is required to use the WIDA screen to access new students who are dual language learners within the first 30 days of school. This information is used to determine academic supports and who will be given the WIDA assessment later in the school year.

# **August 12th - September 20th**

Kinder Readiness (first 60 days) AAK uses GOLD to provide Kindergarten Readiness information to our staff and the state of Colorado. This information is used to determine appropriate academic supports.

# January 13th-17th

DIBELS MOY Grades K-5 Districts must annually report the READ Act administered interim and diagnostic assessments along with the core, supplemental, and intervention instructional literacy programs for grades K-3 for each school operated by the LEP (including charter schools)

### January 13th-January 24th

i-Ready K-5 Diagnostic (Reading and Math) AAK uses iReady as a local assessment to gather baseline and diagnostic data on our students to support data driven decision making. This data is used when creating and evaluating our Unified Improvement Plan and creating academic interventions for our students.

# January 27th - February 7th

ACCESS/WIDA AAK and the State of Colorado uses WIDA/ACCESS as a standardized measurement of a student's ability to access and use the English language. This information is used to determine programming and academic growth.

#### February 18th-19th

NNAT 3AAK uses NNAT3 as a screener for our Gifted and Talented Program. All schools in the state of Colorado must screen all students to support in the determination of qualifying for GT programs. AAK screens all 2nd grade students and students who are new to AAK.

#### April 7th-24th

CMAS Grades 3-5 The state of Colorado requires all schools to administer CMAS to all 3rd-5th grade students. CMAS scores are used at the state and local level to help determine student academic growth and achievement as well as the schools ability to deliver instruction. Scores are analyzed at a school level, district level, and state level.

#### May 5th-16th

DIBELS EOY Grades K-3 Districts must annually report the READ Act administered interim and diagnostic assessments along with the core, supplemental, and intervention instructional literacy programs for grades K-3 for each school operated by the LEP (including charter schools)

#### May 19th-30th

i-Ready K-5 (Reading and Math) AAK uses iReady as a local assessment to gather baseline and diagnostic data on our students to support data driven decision making. This data is used when creating and evaluating our Unified Improvement Plan and creating academic interventions for our students.
