PHOTO AND VIDEO RELEASE

I authorize Aspirations Dance Company to photograph and record my child during classes, rehearsals, performances, competitions, and studio events. I grant Aspirations Dance Company permission to use my child's image or likeness in print materials, advertisements, social media, websites, and other promotional materials without payment or compensation. I understand that these materials may be edited and will become the property of Aspirations Dance Company.

MEDICAL AUTHORIZATION

I have disclosed on the Registration Form any medical conditions, allergies, injuries, or other health concerns of which the studio should be aware. In the event of an accident or emergency, I authorize Aspirations Dance Company and its representatives to obtain emergency medical treatment and arrange transportation to a medical facility for my child if I cannot be reached. I understand that I am responsible for all medical expenses incurred on behalf of my child.

ASSUMPTION OF RISK AND LIABILITY WAIVER

I understand that participation in dance, tumbling, acrobatics, conditioning, rehearsals, performances, competitions, and related activities involves physical activity and carries inherent risks. These risks may include, but are not limited to, falls, collisions, sprains, broken bones, head or spinal injuries, other serious bodily injuries, and, in rare circumstances, death.

1. I voluntarily allow my child to participate in these activities and knowingly assume all risks associated with participation. I certify that my child is physically able to participate and agree to inform Aspirations Dance Company of any condition, injury, or limitation that may affect my child's participation.

2. To the fullest extent permitted by law, I release and agree not to sue Aspirations Dance Company, including its owners, directors, employees, instructors, agents, volunteers, and representatives, for claims, injuries, damages, losses, or expenses arising from my child's participation in studio activities or use of the studio's facilities, equipment, or property, including claims resulting from ordinary negligence.

3. I agree to indemnify and hold harmless Aspirations Dance Company and its owners, directors, employees, instructors, agents, volunteers, and representatives from claims, damages, losses, liabilities, or expenses arising from my child's actions or participation in studio activities.

I understand that this waiver is intended to be as broad as permitted by Illinois law. If any portion is found to be invalid or unenforceable, the remaining portions will continue in full force and effect.

STUDIO POLICIES

Attendance and Absences: Regular attendance is expected. No refunds or account credits will be issued for missed classes or absences. Students should arrive on time and be picked up promptly after class.

Class Placement: Aspirations Dance Company reserves the right to determine appropriate class placement based on a student's age, experience, ability, maturity, and the recommendation of studio instructors. Class placement and schedules may be adjusted when necessary.

Dress Code: Students must follow the required dress code for each class, including appropriate dancewear, shoes, and hair requirements. Students who arrive without proper attire or footwear may be asked to observe the class.

Behavior and Conduct: Students and families are expected to treat instructors, staff members, dancers, and other families with respect. Disruptive, unsafe, threatening, bullying, or inappropriate behavior will not be tolerated. Aspirations Dance Company reserves the right to remove a student or family from the program when conduct negatively affects the safety or well-being of others.

Arrival and Pickup: Parents and guardians are responsible for ensuring students arrive safely and are picked up promptly. Aspirations Dance Company is not responsible for students before their scheduled class begins or after their class ends.

Illness and Injury: Students should not attend class when sick, contagious, or unable to participate safely. Parents or guardians must notify the studio of any injury, medical condition, or physical limitation that could affect participation.

Studio Closures and Schedule Changes: Aspirations Dance Company reserves the right to cancel, combine, reschedule, or change classes, instructors, or studio assignments when necessary. Information regarding weather-related closures or schedule changes will be communicated to families. Studio closures do not automatically entitle families to refunds or account credits.

Personal Property: Aspirations Dance Company is not responsible for lost, stolen, or damaged personal belongings. Students should clearly label their belongings and avoid bringing unnecessary valuables to the studio.

Dressing Room and Facility Safety: Cameras, cell phones, and recording devices are strictly prohibited in dressing rooms, bathrooms, and changing areas. Students and families must follow all posted facility rules and staff instructions.

Communication: Families are responsible for maintaining current contact information and reviewing studio emails, messages, announcements, and other communications regarding classes, payments, closures, performances, and studio events.

Right to Refuse or Discontinue Enrollment: Aspirations Dance Company reserves the right to refuse enrollment or discontinue a student's participation when necessary due to unpaid balances, repeated policy violations, unsafe conduct, or behavior that disrupts the studio environment. No refund or account credit will be issued following dismissal from the program.

TUITION, CANCELLATION AND REFUND POLICY

Tuition is charged monthly on or around the 1st of each month. Payments received after the 5th of the month are considered late and will be subject to a \$25 late fee. All tuition payments are final. No refunds or account credits will be issued for missed classes, absences, holidays, schedule changes, withdrawal after tuition has been charged, or dismissal from the program.

To discontinue enrollment and prevent the next month's tuition charge, a completed Cancellation Form must be submitted to Aspirations Dance Company at least 10 days before the 1st of the month. Verbal notice, text messages, emails, or notice provided to an instructor will not be accepted as official cancellation. Parents or guardians remain responsible for all tuition and fees charged before the cancellation becomes effective.

PARENT/GUARDIAN ACKNOWLEDGMENT
