# Step 1

## Entering Medications

*Watch walk through video available online.*

- Go to Medicare.gov  
Click the “Find Plans Now”
- Enter your medications, strength, quantity,  
and if brand name or generic.
- Enter your preferred pharmacy.

### Important pointers

If you want a brand name be sure to list brand and double check that you have entered all your medications (including eyedrops etc.)



If no current medications put in Amoxicillin for 30 pills a year so you can compare results



## Step 2

### Reviewing Results

*Watch walk through video available online.*

- Scan results (based on your medications)
- Review all plans that cover your medications

#### Important pointers

Make sure your medications are covered.

What is the deductible?

What are copays at a preferred pharmacy?

What is your total medication cost for the year?

What is your copay plus premium for the year?

Does the part D waive deductible for Tier 1 generic medications?



#### Keep in mind

If you have a large number of medications or a few very expensive ones you might want to consider a non-deductible plan.

If all of your medications are covered they will count towards the \$2000.00 out of pocket maximum for the year.

Once this requirement is met all medications will be \$0.00



## Step 3

### Enrollment in Plan Selection

*Watch walk through video available online.*

- Enrolling in the selected Medicare Part D Plan
- Select your plan and push enroll

Option: If you do not have or use a computer you can call 1-800-Medicare (1-800-633-4227) and they can enroll you in a part D plan.
