

FEE SCHEDULE

The following Fee Schedule offers a list of all our currently offered services and is subject to change as we adjust prices due to market value and average insurance reimbursement rates for our services. We do not require that you use Sulcata Psychiatry to complete ordered testing. Pricing to be reviewed annually. Last update 7/1/22

Medication Management Services	Cost
Intake Visit 60 minute visit, in-person or via telehealth, with the provider for diagnosis and evaluation with treatment and medication management as appropriate. Also includes physical evaluation as needed, ordering of labs/diagnostic tests/imaging, referrals as appropriate, and brief therapy interventions.	\$350
Follow-Up Visit 20 minute visit, in person or via telehealth, with provider to evaluate progress, treatment goals, and provide medication adjustments	\$175
Extended Follow-Up Visit 40 minute visit with provider to evaluate progress, treatment goals, and medication adjustments for those who require more time with the provider, lengthy therapeutic intervention, or have a more complex presentation	\$225
Psychotherapy Services	
Intake Therapy Visit 75 minute visit, in person or via telehealth, with licensed psychotherapist to clarify problems, goals, and develop treatment plan for patient diagnosis	\$200 - LCSW \$150 - LPC-A
Follow-Up Therapy Visit 50 minute visit, in person or via telehealth, with therapist to continue therapy interventions, development of coping skills, and working towards treatment goals	\$150 - LCSW \$100 - LPC-A
Family Therapy Visit 50 minute visit, with or without patient present, with therapist to continue therapy interventions, gather outside information, and work on family systems	\$175 - LCSW \$110 - LPC-A
Multidisciplinary Therapy Visit 40 minute visit with both the medication management provider and the therapist present, can include family members. Helpful if more intensive work being done, lack of progress, or need for clarification regarding treatment plan goals.	\$300

Diagnostic Testing Services	Cost
Diagnostician Psychological Testing 3 hour visit, in person, with Masters prepared Registered Behavioral Technician and Diagnostician. Customized psychological testing batteries for diagnostic clarity or implementing school (504/IEP/ARD) or workplace supports & benefits. Diagnostic report for school or work included.	\$450
Diagnostician Accommodation Recommendations Report In addition to the diagnostic results report from Diagnostician Testing. Includes recommendations for school or workplace accommodations that would be beneficial in treatment.	\$50
School Accommodations Consultation 60 minute in-person visit with parents to discuss initiation or navigation of school system supports, interpreting and implementing 504/IEP plans, preparing for ARD meetings, and advocating for their children to get them the supports to be successful.	\$150
Computerized Cognitive Testing Computerized testing to evaluate symptomology for executive function and cognitive deficits. Must complete for ADHD diagnosis.	\$100
Lab Services	
Blood Draws Requires a scheduled time to come in person, can be done quickly within the span of 15 minutes. Lab Testing is part of a comprehensive evaluation of health and medication management.	\$20
Urine Drug Testing - Confirmation Send Off to Lab If your in-office point of care test is inconclusive or if there is a positive unexpected result, the specimen will be sent for testing at an outside lab for clarification of results	\$80
Urinalysis – Infection or Pregnancy with Confirmation Requires a scheduled time to come in person, but can be done quickly within the span of 10 minutes. Urine Dipstick testing for pregnancy or urinary tract infections, with subsequent send off to outside lab for confirmation if result is positive in office.	\$30
Genetic Testing Swab Requires a scheduled time to come in person, but can be done quickly within the span of 10 minutes. Pharmacogenetic testing done with mouth swab and sent to Genomind lab partner to determine genetic response to medications.	\$20
Injections – Vitamin or Medication Injectables require a scheduled time to come in person, but can be done quickly in the span of 10 minutes. *We do not require that you utilize us for prescribed injectables.	\$20

 Medical Records Requests for physical printing of chart records to patient 	\$20 for 10 pages, adtnl \$0.50 per page
Fillable Forms requested for various reasons (i.e. disability paperwork, FMLA, attorney documentation requests, etc.)	\$5 per page
Original Provider Drafted Letters explaining patient symptomology, provider insights, prognosis, progress, and/or treatment plan, etc. that may be requested for various reasons (i.e. disability appeals, attorney requests, custody evaluations, etc.)	Billed at set rate \$100/HR based on time to draft the request
"Rush" Request fee to guarantee completion of forms in less than 3 business days	\$10
