Access to livestock area and trailer area will be through the livestock parking gate, gate 1 at the east-end of Spruce Street. You will get parking and admission passes when you check in at the livestock office on Tuesday.

No trailer will be allowed to park on the fairgrounds prior to **Sunday, August 20, 2023**. Gates will close at **3 p.m. on Sunday, August 20, 2023** no trailers will be received after that time on Sunday. No overnight guests will be allowed on Sunday. Gates will re-open **Monday, August 21<sup>st</sup>, at 8a.m.** There is no security on the fairgrounds until Monday, August 24<sup>th</sup>; the livestock office will not be open on Sunday. All trailers must be removed from the fairgrounds by **Monday, August 28, 2023 before 3 p.m., Fees will be assessed after that time.** Trailers must park within the assigned designated space. Trailers unable to fit within their space or trailers that are over the designated lines may be asked to move or readjust to fit within the lines. Empty spaces, not filled with a trailer/camper, will be subject to resale. All requests for refunds must be received ten days prior to fair or no refund will be granted. Management has the right to refuse RV space.

**No stock trailers in the RV Park or along the barn fence lines.** Stock trailers defined as any unit used for livestock purposes without permanent living quarters defined as kitchen, restroom and sleeping quarters. To make accommodations for stock trailer requests, we have reserved spaces just east of gate 11. Stock Trailers limited to not more than 38' in length including tongue and rear ramp. Units will be placed by forklift. **Limited availability.**  
**NO OVERNIGHT PARKING ALLOWED IN ANY AREAS NOT DESIGNATED FOR OVERNIGHT PARKING. VIOLATORS WILL BE REMOVED FROM FAIRGROUNDS. AT FAIRTIME, VEHICLES MUST BE OFF THE FAIRGROUNDS PROPERTY BY 7:30 A.M EACH MORNING OF THE FAIR. Auto and truck parking for the livestock exhibitors will be provided in the infield area only. NO VEHICLES ARE TO BE PARKED IN THE TRAILER/CAMPER SPACE AREA.**

 I request permission to remain on the fairgrounds at night for the duration of the Butte County Fair. I will abide by all the rules prescribed by the Fair Association.
