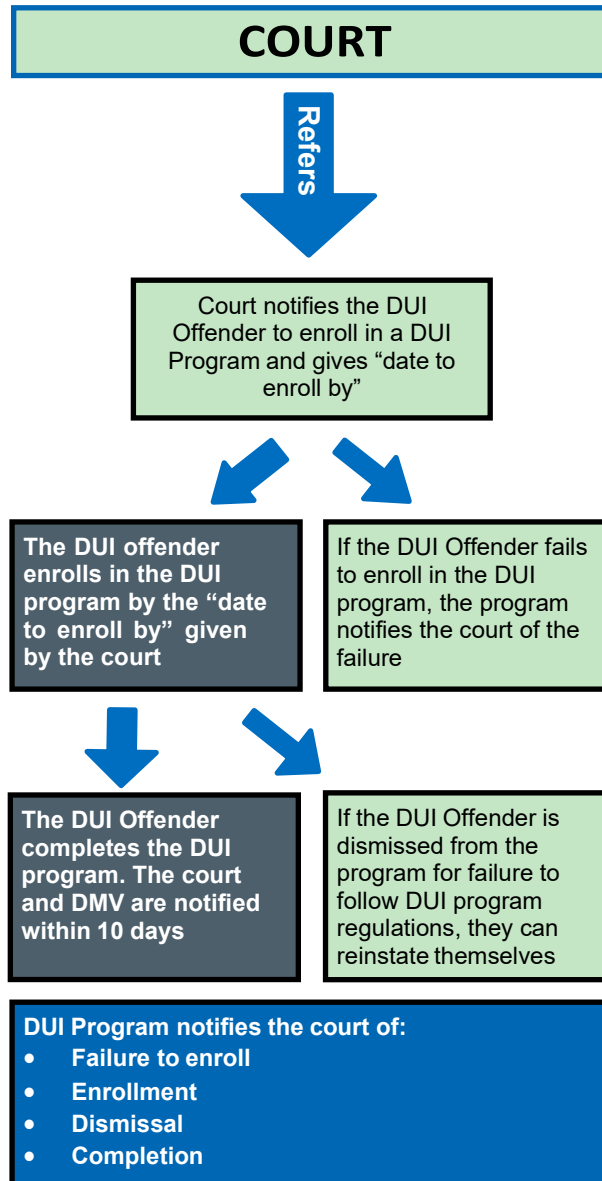

- Down payment. Check with the program of your choice for the amount to bring.

Failure to enroll within 30 days of your court appearance AND failure to successfully complete your DUI program may result in a warrant for your arrest, additional penalties and will impact your driving privileges.

## **STATE LICENSED DUI PROGRAMS**

The Santa Clara County Driving Under the Influence Programs are here to assist you in completing your court-ordered and DMV requirements and help reduce future DUI's.

Driving Under the Influence Programs are located throughout the County of Santa Clara. Services are provided to persons convicted or awaiting conviction for Driving Under the Influence. Wet Reckless, First, and Multiple Offender Programs are provided in English, Spanish, and Asian languages at several locations within Santa Clara County.

To comply with the requirements of the courts and/or the Department of Motor Vehicles, attendance and completion of all program sessions are required.

Only programs that have been approved by the County and are licensed by the CA Department of Healthcare Services are eligible to provide these services.

No one is denied services for documented inability to pay. Payment plans may be arranged. Program fees may vary throughout the county. Please call in advance to schedule an appointment for registration.

### ***Department of Health Care Services***

**Overview:** The objective of the Driving Under the Influence (DUI) Program is to: (1) reduce the number of repeat DUI offenses by persons who complete a state-licensed DUI program; and (2) provide participants an opportunity to address problems related to the use of alcohol and/or other drugs.

**Objective:** These programs are designed to enable participants to consider attitudes and behavior, support positive lifestyle changes, and reduce or eliminate the use of alcohol and/or drugs.

### **IMPORTANT NOTICE**

The State of California does not recognize any "Online" DUI courses. The DMV will not grant or reinstate a Driver's License without official notice from a California Licensed DUI Program.

## **WHAT TO EXPECT**

State Licensed Driving Under the Influence programs provide education, group counseling and individual case management and an individual substance use assessment.

The goal of the DUI program is to encourage your exploration of the relationship between alcohol/drug use and the inherent risks involved resulting in modified drinking/drug use in high-risk situations such as driving.

Program length is based upon Blood Alcohol Content (BAC) and Vehicle Code prior DUI convictions.

### **The Wet Reckless Program:**

Persons convicted of a reckless driving offense with a measurable amount of alcohol in their blood.

- Complete a 12-hour DUI alcohol and drug education program.

### **First Offender Program:**

Persons convicted of a first DUI offense will complete one of the following programs:

- Three-month (30-hour)
- Six-month (44-hour)
- Nine-month (60-hour)

Each program requires:

- 12 hours of alcohol and drug education
- A minimum of 10 to 44 hours of group counseling
- Individual counseling interviews

### **18- Month Multiple Offender Program:**

Second and subsequent DUI offenders are required to:

- Complete a 18-month multiple offender programs with 12 hours of alcohol and drug education
- 52 hours of group counseling
- Biweekly individual interviews
- 6 hours of community reentry monitoring

**Please Note:** Additional hours or services may be required by the county.

## **REFERRAL AND ENROLLMENT**

The purpose of the enrollment session is to explain the DUI program requirements, complete your enrollment paperwork and help you choose your schedule of program activities. There is a fee for your program.

### **Court Referral Enrollment**

At the enrollment session you will need to provide your court probation order paperwork.

### **DMV Referral Enrollment**

If you are no longer under the supervision of the court or Probation Officer, and want to enroll into a DUI program, you must obtain a DMV H-6 print-out, which you would request at your local DMV Office.

### **DMV Admin Per Se Referral**

#### **For First Offenders Only**

Did you know that you may be eligible for a restricted license if you sign up for a DUI program?

The DUI Program will accept the Admin Per Se form (generally a pink temporary driver's license provided at arrest) if you would like to enroll in a DUI program prior to your court appearance.

### **DUI Program Fees**

The cost of your DUI program is determined by which length of program the court or DMV requires.

There is a down payment required at the time of your enrollment appointment. If you need financial assistance, please inquire with the selected DUI program.
