Ron presented the treasurers report. Contributions were down from last year but over on what was budgeted for the year.

- Eric made the motion to approve the treasurers report; Lynn 2<sup>nd</sup>; Motion approved.

Eric presented the Pastels on 5<sup>th</sup> Event Sat Sept. 7th, which benefits Alternatives to Violence.

- Ron made the motion that we give \$250 to sponsor a space for chalk art for this event. Jan 2<sup>nd</sup>; motion carried. Monies to come from Community outreach budget.

Safety Team: Eric made the motion to allow KOG small groups back in immediately, and phase in outside groups in July. Randy seconded. Motion passed.

Bryan presented the resume and cover letter for Trey Tafoya, the candidate for our Social Media/AV position. Judy made the motion to offer the position to Trey. Lynn seconded; motion carried.

Pastor Deb presented events scheduled currently: Faith Day at the Rockies, Labor Day Retreat at Sky Ranch, and the Women's Retreat at YMCA this fall.

Pastor Ruth Ann plans for June worship. Saturday not to exceed 75 people max, Sunday 8:30 am, Adult Education 9:45, and Saturday 11 a.m. not to exceed 75 people.

- Judy made the motion that we approve the summer worship guidelines, Joe seconded, motion approved.

The bazaar team has recommended that we do not host the bazaar this year due to safety issues. Eric and Bryan will send emails to Pr. Ruth Ann to support the bazaar team's decision.

There is \$1700.46 in the Faith Formation budget (301.009). There is a need for money for scholarships for camp and youth mission trip.
