### YRSA / TSA SOCCER INDOOR DEVELOPMENT COMPETITION TEAM INFORMATION

**Acceptance of Application:** Clubs that have submitted a properly completed application, accompanied by the required team application fees, issued by club cheque or e-transfer, will be considered for entry into the Indoor Development Competition.

**Late Registration:** Late applications must be submitted including a late application fee of \$200. Late applications will be accepted at the sole discretion of the YRSA/TSA League Operations Committee.

**Acknowledgement of Rules:** All clubs, by submitting this application, agree to abide by the YRSA/TSA playing rules and agree to be governed by YRSA/TSA and OSA Policies & Procedures.

**Matches & Schedule:** 14 matches for all playing formats; Schedule to be determined at close of registration and dependent upon number of teams registered in each age group.

**Team Bond:** For team registered outside the YRSA/TSA, a bond of \$200 must accompany the application form. Teams from outside the YRSA/TSA will require a playing out permission form.

**Team Withdrawal:** THE APPLICATION WITHDRAWAL DEADLINE WILL BE STRICTLY ADHERED TO.

- Teams withdrawing after submitting their application prior to September 23 will be refunded.
- Teams withdrawing after September 24, 2025, will lose the full registration fee.
- Teams withdrawing after November 24, 2025, will lose the full registration fee and incur a \$1,000 fine for their club.

**Cancellations:**

- If YRSA/TSA cancels the season due to a medical emergency before it starts, clubs will receive a full refund.
- If YRSA/TSA cancels the season due to a medical emergency during the season, clubs will receive a pro-rated refund based on the number of remaining games.
