Grades Pre K to 5th: \$26,250 (Cash/ACH), \$27,040 (Credit Card) Grades 6th to 8th: \$28,650 (Cash/ACH), \$29,540 (Credit Card)

Payment Details:

- All fees are non-refundable.
- Annual Registration Fee is due at the time of registering for the 2025-2026 academic year.
- Automated Clearing House (ACH) is mandatory for tuition payments unless paid by cash or credit card.
- First month's tuition, Supply Fee & Annual Elective & Technology Fee are due July 28, 2025.
- Tuition payments received after the 5th of the month will incur a \$50 late fee.
- Annual Supply Fee and Elective & Technology Fee received after August 1, 2025 will incur a \$25 late fee.
- Any payment returned by a bank (for any reason) will incur a \$50 service fee as well as a \$50 late fee.
- Monthly tuition is non-refundable; NO pro-rating/refund for missed school days, holidays, early withdrawal (early withdrawal requires a 30-day written notice), or any local to national emergencies or disasters.
- Extended day care ends exactly at 6:00 p.m. Late pick-ups will be charged \$20 for every 15 minutes, payable on site.
