- 5. In the event the installment of tuition is not received when due, The Britleys retains the right to cancel The Student's enrollment and pursue collection of tuition through a Collection Agency, Attorney, or any other Legal Remedy. In the event the tuition under this contract is not paid when due and is collected by a collection agency or an attorney or by suit, principals, sureties, and endorsers, The Parents agree to pay a reasonable fee for the collection for the same.
- 6. The Parents agree to pay the annual Non-Refundable Registration Fee of \$100 per student with the submission of this signed contract. In the case of sibling enrollment, it will be \$150 for the family registration fee in place of the single student fee. The Parents also agree to pay the non-refundable fee of \$500.00 at the time of enrollment to hold The Student's slot in the program. This will be applied to the activities and events at school.
- 7. With respect to the obligation of The Parents to pay the entire tuition required under this contract, a written thirty-day (30) notification of withdrawal must be given to The Britleys, or all tuition will be due and collected and this contract will be held binding.
