Terms of Contract:

- 1. The consignor authorizes Maven Coco to sell all goods consigned. All unsold items after the contract end date may be heavily discounted or donated.
 - 1.1. Maven Coco shall do its best to sell items before eventually donating any unsold items.
 - 1.1.1. **During** the consigning period, items may be discounted to a maximum of 15% off the initial listing price.
 - 1.1.2. **After** the contract end date, items may be discounted to a maximum of 50% off the current listing price.
 - 1.1.2.1. Current listing price = price of item listed on tag. (May be on a sale rack at a reduced price, or noted as discounted)
- 2. Consignment periods are 3 months. Consignors are to receive 40% of final sale price.
 - 2.1. Contract end date will be 3 months after contract start date, same day. (Example: Start date: 5/3/25, End date: 8/3/25)
 - 2.2. All unsold items will be kept in store for a grace period of 2 months after the contract end date in attempt to sell items before donation.
 - 2.2.1. During the grace period, items will **not** be donated and may be put on a sale rack at a reduced price and/or be sold discounted.
 - 2.2.2. After the 2 month grace period, items may be donated to a charity thrift shop.
 - 2.3. Final sale price = final price of item when sold, which may include reduced prices and discounts subtracted from the initial listing price.
 - 2.4. At any point during the consignment period, if consignors decide they want certain items back, they may pick up their items they find in store. Maven Coco staff will not retrieve items in store for consignors, consignors shall retrieve such items themselves.

- 3. Final pricing of consigned items is to be determined by Maven Coco staff.
 - 3.1. Consignors may advise on pricing of unique items, but listing price is ultimately determined by Maven Coco staff.
 - 3.2. Prices are typically determined by both the retail price and resell price of similar items online.
- 4. Consignors are responsible for contacting Maven Coco for their payouts.
 - 4.1. Consignor payouts are available for pick-up by cash if it's \$30 or less, otherwise payouts will be sent electronically through Venmo, Zelle, or Cashapp.
 - 4.1.1. Alternative payout options may be discussed if necessary.
 - 4.1.2. Consignors have the option to turn payouts into store credit and apply it towards purchases in store.
 - 4.2. Consignor payouts are trackable online. If unable to access, Consignors may call or visit in person to know how much Consignor credit they have available.
 - 4.3. Money not collected within 6 months of contract end date will be forfeited.

- 5. Consignors leave all items at their own risk. Maven Coco is not responsible for consigned items in case of theft, destruction of, or damage to consigned items.
- 6. Each consignor may bring up to 10 season appropriate items per week. All items must be clean, without stains or any damage.
 - 6.1. Consignments are by walk in or by appointment on Tuesdays.
 - 6.2. Items will be inspected when brought in for consignment. Items that are stained, damaged, or not season appropriate will not be accepted.
- 7. All consigned items not sold or picked up will be donated some time after the 5 month mark.
- 8. Consignors may log in at www.mavencoco.com to view their inventory list, item status, credit available, payout history, and even purchase history.
 - 8.1. Consignor usernames shall be consignor first and last name, no spaces, no special characters, and all lowercase.
 - 8.1.1. Example: janedoe
 - 8.2. Consignor passwords will be set to first initial capitalized, full last name with first letter capitalized, @ sign, consignor phone number.
 - 8.2.1. Example: JDoe@1234567890
 - 8.3. Purchase history may be empty. When buying items in store, give your first and last name so purchases will be recorded under your account and earn rewards credit. \$0.20 for every \$10 spent in-store, which may go towards future purchases.
